Terms and Conditions of this agreement are as such:

The guardian takes on a full responsibility to care for the dog's well being, training, medical bills, vaccination, food , water, supplements, shelter.

During each time the female becomes in heat the guardian must make the owner aware immediately .

on the 10th day from the onset of heat the dog must be brought to the owner to be fertilized, the female can be picked up 5 days later.

If a female dog has an accidental encounter with another dog of the same or another breed, the guardianship program will be considered breached and terminated, the dog must be brought back to the owner.

During the stay with the guardian the dog must receive her pregnancy supplements (prenatal, folic and puppy food only)

Both parties must stay in touch on weekly bases. Once it is confirmed that the female is pregnant the guardian must bring her back to the kennel on the 58th day from the first counter with the stud or if her temperature dropped bellow 99F

If the female goes into labor and you can't reach French Bulldogs inc you must call this number and drive her to the vet for a Section: Integrity Animal Hospital, ask for DR.Nunn Kingsland GA

The mama dog and her puppies will stay with French Bulldogs inc for 6-7 weeks

If you must leave town and or state for any reason you must bring the dog back to the breeder unless the short trip proven , confirmed and the permission was given by the breeder.

In case of death of the dog during the guardianship an autopsy must be done to confirm (costs paid by guardian) your innocents in the situation

IN _____

The puppy cost is _____ , if the dog goes missing, stolen, it will be considered to be a felony and treated as such, you will be held responsible for the attorney and court fees.

IN _____

This dog is considered to be a lease and is a full property of French Bulldogs inc until the terms of this agreement have been met , the dog's ownership will be released to the guardian after her 3rd litter is born and raised and alive of 4 or more puppies. If the litter is less than 4 survived pups than the dog will be bread the 4th time. After the rights have turned in to the guardian the dog becomes a full property of the guardian free of cost.

If the dog doesn't get pregnant 2 times on a raw then the dog will go for sell and you will have the first right of refusal it will be 35% of the cost of the price of the puppy. IN _____
